NOTICE TO BIDDERS

Sealed bids for Contract No. 4568.15, for the Legion Park Improvements Project which includes construction and renovations to the existing park located in Rhinebeck, NY 12583 are sought and invited by the Village of Rhinebeck, Dutchess County, New York, as set forth in specifications dated July 11, 2018, prepared by Crawford & Associates Engineering, P.C., 4411 Route 9, Suite 200, Hudson, New York 12534.

Bids will be received at the office of Patricia Coon, Village Clerk; 76 E Market Street Rhinebeck, New York 12572 until July 27, 2018 at 3 PM . The bids will be publicly opened and read aloud immediately thereafter at the Village Hall located at 76 E Market Street Rhinebeck, New York 12572.

The Village of Rhinebeck is requesting bids for the reconstruction of the construction and renovations to the existing park located within the Village of Rhinebeck. The modifications to the site include selective demolition, construction of new pathways, asphalt paving, fence installation, tree relocation, and installation of a ADA fishing dock. All activities on site shall be consistent with State and Federal regulations.

All bid documents and all contract documents, including specifications governing the contract (Bid Documents), may be examined during regular office hours at the office of the Village Clerk, 76 E Market Street Rhinebeck, New York 12572, between the hours of 9 a.m. and 4 p.m., on or after July 11, 2018. This job is subject to prevailing wages. Wage rates are provided within the Bid Documents.

Copies of the Bid Documents on paper or digital may be examined and obtained from the office of Crawford & Associates Engineering, P.C., 4411 Route 9, Suite 200, Hudson, New York, upon making a deposit of fifty (50) dollars for each set of specifications obtained. All payments shall be in the form of a check or money order made payable to Crawford & Associates Engineering, P.C.

Starting promptly at 10:00 a.m., prospective bidders are advised that there will be a mandatory pre-bid meeting on July 13, 2018, at Legion Park located within the Village of Rhinebeck, NY 12572. All questions from the pre-bid meeting will be answered in writing via email within one week of the meeting. Questions after the pre-bid meeting can be sent via email to Ryan Loucks of Crawford and Associates (rloucks@crawfordandassocaites.com) until July 20, 2018 at noon.

Each bidder must provide a security deposit with her/his bid in the amount of not less than five percent (5%) of the base bid in the form of a certified check or a bid bond subject to the conditions of the bid documents.

No bid will be accepted unless a signed Certification of Non-Collusion is submitted with the bid.

The Village of Rhinebeck expressly reserves the right to waive any informality in or to accept any bid or to reject any and all bids or to award on any or all items as the interest of the Village may appear to require.

No bidder may withdraw his bid within forty-five (45) days after the actual date of the bid opening.
